Career Education at the GSB: New Vision, New Opportunities

Providing premier career education to alumni has always been a goal of the Office to Advance Career and Corporate Alliances (OACCA), and to better reflect this commitment, OACCA became the Career Development Office (CDO) on January 1. In addition to our new name, we have launched this career column to present information and practical ideas to support your ongoing career success.

The CDO provides the following programs and services:

Career Assessments. Assessments can help you evaluate yourself and your career, from clarifying your direction and choosing organizations compatible with your strengths to finding your passion and improving your interpersonal skills.

Individual Career Coaching. This can help you advance within your company, find a new position, or make a complete career change. Sessions can be conducted via phone from anywhere in the world.

Career Strategy Workshops. Workshops are a low-pressure way to begin to build or strengthen the skills you need to succeed in today's marketplace. They give you an opportunity to explore a variety of career topics, from resume writing and interviewing to how your values affect your career choices and how to market yourself.

Resume e-Directory. This listing includes alumni and eligible part-time students and is sent to more than 1,100 companies and 260 executive search firms. This online directory allows recruiters to search for candidates based on a variety of criteria, including background, functional experience, and years of professional work.

Job Opportunities. The GSB learns of new opportunities daily, posting more than 2,700 job openings annually that range from entry-level M.B.A. to senior-level executive positions. These openings represent various job functions and industries from both domestic and international organizations.

Corporate Insights and Industry Immersion Panels. These events are held throughout the year in Chicago, Barcelona, and Singapore. Companies visit the GSB to provide alumni and students with firsthand information about their industry, culture, and business strategies. The Industry Immersion Panels create opportunities for students to network with alumni in a variety of industries.

The Fisher Library. Located at Gleacher Center, the library provides extensive career- and job-related research resources to alumni around the world. If you live in or visit Chicago, you will find a comfortable place to conduct your career research. Connect your laptop computer to a port, or use one of the computer workstations to access online databases featuring company information, job leads, industry data, and compensation surveys. Alumni have full access to these resources from the library's computer workstations. If you're not in Chicago, the Fisher Library provides long-distance support for your career research needs. Professional librarians are available for reference assistance and database instruction. The library also offers a circulating collection of career-oriented books and videos.

New York Chapter Honors Sherman R. Lewis Jr., '64

For the second time in its 25-year history, the Chicago GSB New York alumni club granted its distinguished alumnus award. In September 2002, it was awarded to **Sherman R. Lewis Jr., '64** (above), vice chairman and director of Lehman Brothers, who was honored for his volunteer efforts to help the GSB and its New York alumni, as well as his success on Wall Street.

"When you speak with people about Sherman, you tend to get words that describe character rather than titles and tenure," **Robert E. Kiernan III, '87**, told the audience. He described Lewis as a man of "intense passion, immense integrity, boundless enthusiasm, focused perseverance, charm, grace, and unswerving loyalty."

Andrea Bass, '78, said after the event that there was "no greater champion" of the GSB's New York club than Lewis, who helped draw speakers including the late Nobel laureate **Merton Miller**. Lewis is an active member of the Council on the Graduate School of Business, a group of top executives that advises dean **Edward A. Snyder** on program issues and provides a link between the academic and management communities.

Lewis has spent 29 years in various senior positions with Lehman Brothers and its predecessor companies, including Shearson Lehman Brothers, Shearson/American Express, and Loeb Rhoades & Company. He has held his current position since 1993.—P.B.

Ruiz-Morales reports: “Tamerlane, the second-largest conqueror of the second millennium after Genghis Khan, had a highly effective business philosophy with which he built his empire from Moscow to Cairo, from Istanbul to Delhi, from Baghdad to Samarkand. Most of his methods would today be termed politically incorrect, like chopping off the heads of the inhabitants of

cities that refused to surrender immediately to his demands. Still, his impressive empirewide communications system, his just-in-time weapons-manufacturing facilities, his scheme of highly centralized controls with highly decentralized decision making, and his policy of joint ventures and revenue sharing with adjacent kingdoms and fiefdoms were all forerunners of today’s modern multinational company.

“Clavijo’s book contains memorable lessons on policy making, diplomacy, negotiation, and strategy. The session was the second of a series where we mingle business topics with pure leadership topics. Thus, following talks on e-business,

new ventures in retailing, and an upcoming talk by the chairman of BBVA on corporate governance, we also have scheduled a talk by a manager of a major NGO charity and a session by Chus Lago, the only woman who has climbed Everest alone and without oxygen.”

William H. Newman, Ph.D. '34, Leading Business Scholar

William H. Newman, widely regarded as one of the most influential thinkers in the field of business strategy and management over the last century, has died. Among his many achievements are the 10 books he authored, including the first business textbooks on strategy and on basic management practices. In his final years, he was working on a book that he hoped would “change the world” by asking people to rethink the “profit maximization mindset.” Newman, who taught at Columbia until his retirement in 1978, also cofounded the Academy of Management. He was offered deanships at Wharton and Chicago, among other leading institutions, and was one of the first four business professors from the West to teach in China after the Open Door Policy was instituted in 1979.

In a eulogy given on June 23, 2002, University of Virginia business professor Ming-Jer Chen said of Newman: “Although he achieved tremendous professional success, he did so with an almost fierce kindness. His professional achievements were matched, and marked, by an equally tremendous goodwill, patience, even-temperedness, optimism, and humility.”—M.L.

Harvey Kapnick, Former GSB Council Member

Harvey Kapnick, a former chairman and chief executive of Arthur Andersen and member of the Council on the Graduate School of Business, died August 16, 2002, near his home in Naples, Florida. He was 77.
